Item 5 - REPORTS

Item 5a - President & NKC Delegate – Stephen King

Dear Members

On Saturday, the 6th of February, 2010 I was appointed by the SKC to the position of President. Also there was a major change in the Executive. I am extremely pleased to report that the State Executive are working as a united team and in the six months since our appointment a positive change has occurred in the administration of our sport.

The introduction of Industry meetings has been positively received and the representatives are making a constructive contribution to the sports administration. We have established more effective communications and this will result in a stronger relationship between the State and Industry.

A meeting was held with Prokart and the NKA and as a result we now have effective communications between all parties and this will result in a more encouraging attitude by all parties. A recommendation has been placed before the SKC to recognise Prokart Licences for the purpose of practice.

We have seen the introduction new State Policies on Duplicity of Duties (State/National), Late Agenda Items, Fixed term of Office and NKC Delegate vote as directed by State.

The CMS License System and Timing System have been introduced and we have had mandatory transponders for approximately one month. This has been positively received and we will see more and more advantages as time goes by. As with all systems it has not been without it's clichés, however the constructive attitude shown by those dedicated club members who are Race Secretary's has seen the system improve and the clichés removed.

The Closed state Titles were introduced for the first time this year and were run by three clubs as a joint venture. These being Coffs Harbour, Manning Valley and Newcastle. The venue was Raleigh International Raceway, special thank to Mr. Chris Piggott for his support and cooperation. My thanks to all those who put in the hard yards to make the meeting a success.

The CIK had two visits to our State, that being Newcastle and North Shore Kart Club/Eastern Creek International Raceway. My Thanks to all the Club Executives and members that made these two meetings the jewel in the crown of CIK. Those who attended the meeting could not fail to be impressed by the whole event. These events had a positive impact on karting with our State and we gained a higher profile in the main stream media. One must acknowledge the efforts of Mr. Peter Galvin and Lee Hanatschek.

The reintroduction of racing at Wollongong had a very encouraging impact on karting within the greater metropolitan basin and the south coast. Please encourage your club members to pay a racing visit to Wollongong, as they need our support.

The Speedway clubs have been steadily growing and extremely active in promoting our sport. The State Titles were run at Nepean Speedway and the National Titles run at Central Coast Speedway. Both were very successful events.

I have attended two National Karting Council meetings as the Delegate since taking office and have been ably assisted by Mr. Peter O'Neal. I believe that we have had a very constructive input into the decision making process. As you are aware, the position of National Karting Council Delegate is to be decided at the AGM. We have received two very high class nominations, they being Mr. Peter O'Neil and Mr. Bob Baker and I am confident that whoever in appointed will be an exceptional delegate.

The Junior Development Program is currently under review and I look forward to the clubs having a positive input. I must commend the Combined Districts Kart Club and Tamworth Kart Club on running very successful camps.

There are many items as work in progress, but some worth mentioning are "Training Class" for 5 to 7 year olds. Strategic planning for 5 and 10 year plans, 2011 Calendar and a new State Series.

I have made a concerted effort to attend race meetings and talk to the competitors and officials. These being Dubbo, Tamworth, Port Macquarie, Coffs Harbour, Wollongong, North Shore, Grenfell, Combined Districts, Newcastle and Raleigh. These visits have been well received and I have gained valuable information to assist with planning.

I was fortunate enough to be invited to the Combined Districts Breast Cancer Presentation Night. The efforts by this club and all those drivers that supported the event are truly outstanding. They have raised in excess of seventy thousand dollars. Well done, Combined Districts and keep up the good work.

We now come to an election of Executive members for the positions of Vice President, Country Delegate, Assistant Country Delegate. I commend to you the incumbent members Mr. Derek Ferry, Mr. Tony Agland and Mr. Steve Fisher. As I have said previously, we have a united and dynamic team that are moving karting forward in this State.

Thank you for the opportunity of serving this sport that we love and I look forward to the challenges of the next twelve months.

Item 5b – Vice-President – Derek Ferry

It has been a busy six months since I have been in the position of vice president.

I'm pleased to say that the new Executive is working well together in our various roles to move karting forward in NSW.

I recently attended the industry meeting held at the state office; it was interesting to hear the views of the trade on how they believe the sport can be improved for the future.

One of the new roles I have taken on since being elected is that of chairman of the Officials Panel, the role of the panel is a challenging one. Our challenge is to allow more officials access to bigger meetings so they can gain the necessary experience so that they can be upgraded. The problem we face at the moment is it is very hard for officials in the country to get exposure to the running of big meetings and it is also very costly for a small club to bring senior officials to their tracks to run their bigger meetings. The panel and I are now looking at ways of how country officials can travel to the city for more training and how city officials can travel to the country to improve their skills without the total cost being borne by the clubs. The panel will be looking into ways that this can be funded.

The other role which I have continued is that of the come and try trailer coordinator. The trailer is still proving to be a useful tool for the clubs to promote themselves in their communities to gain much needed members. In the last twelve months I do not know of any club that has used the trailer that has not gained new members, so I urge all clubs to continue their use of the trailer. I would also like to thank Chris Dell of CRG Race Centre and George Turton of ARROW karts for their continuing support of the come and try trailer.

I'm still working with Terry Werner from Canberra Grammar School. Terry has been running this course now for three years where he takes ten students and teaches them all aspects of karting as well as eight practice days and one race day. I would also like to thank Canberra and Grenfell Kart Clubs who have been of great assistance to Terry in the running of this scheme.

Item 5c - Treasurer – Max Laybutt

Unfortunately I need to write this report before the end of the year so that the girls can get it into the meeting agenda, as such we have not yet received our end of year financial report from the Auditors, and it is that upon which we will construct our budget for the following year.

With all that in mind I would request your understanding, and promise that we will prepare a full financial report, and budget for your information as soon as possible and certainly before the actual meeting so that you will have time to digest the results and make comments upon them at the AGM.

There are still some points which I will confirm and present at the AGM that you should be aware of. I said at the beginning of the year that the loss of a second facility in the Sydney Basin would certainly cost us this year, and will be a major concern going into the future.

As a Guide in 2009 we had, near enough, 14,000 participations, up until the end of May 2010 we had 11500, give it another 400 for June (Coffs was near enough 200) and we have a shortage of 2,100 @ \$13.50 = \$28350.00 which we need to make up.

Contained in the 11,500 was an amount of 1240 for the 2nd Sydney venue, a portion of which should be considered a shortfall, say 50%? 620? Plus 2100, x \$14 = \$38080.00 which we may have to shorten the budget by for the coming year..... Or?

Certainly needs a close watch on spending, and some major discussion to ensure we continue to maintain the good financial position of our past.

I sincerely want to thank you all for your willingness in getting the "CARD" into being, and the transponder issue is fast proving to be a very worthwhile exercise, which will only get better and better as people become more familiar with the system, and our Card Team gets to complete all the goodies that we have planned.

It was pleasing to see that our National Body has approved important expenditure for other card improvements, The Web based Result information section is due for completion in the next few weeks, the latest stewards section will then be worked on for completion of the "on Line" training section, and then the big one..... DATA COLLECTION that is when the BULLDUST stops!

To make this all happen I, personally will need to extend my time on the National Executive for a further 12 months, and so I will be standing for election at the next National AGM so that I can complete the Card program.

Unfortunately, in line with your Presidents policy which you have supported, if I am elected to that position I will need to forgo my position as your State Treasurer. I must say this is disappointing to me for I had hoped to at least see out my current term as your Treasurer however I hope you all understand that the completion of the Card System is of immense importance to me as I sincerely believe that it is already providing tremendous benefits to our sport, and its completion will take our sport into a new and exciting world of true facts which we will be able to better build our sport upon.

I could not complete any report without heaping lots of praise on all of our office girls, everyone knows the undying efforts of Karen, and from my treasurer perspective, Debbie Wilkinson has just been marvelous with the accounting and you can all rely on what she produces for you, Debbie Hutt, well what do you say other than the "Card" system would never have worked without her ever reliable input, and Now Donna who makes you feel welcome the moment she answers the phone, and has taken to our sport with a great desire to learn all she can. To all of them from myself MANY THANKS FOR A GREAT EFFORT.

Item 5d – Metro Committee Member – Peter O'Neill

In the few short months that I have been accountable for the Metro Member position I have had the opportunity to help the President and the other members

of the Executive carry out the day to day responsibilities that are integral to the success of karting in NSW.

These include decisions that impact on individual karters and individual clubs and on the SKC generally, in addition I have been fortunate to accompany Steve to the National Karting Council conferences where I think we have successfully represented NSW on decisions that affect not only our members and our clubs, but affect the sport of karting both domestically and internationally.

We argued in favour of the track loan for North Shore Kart Club where there was clearly opposition to the loan from some of the other states and in doing so the loan was eventually approved by the NKC.

We also voted in favour of the Grenfell Club and Tamworth Club track loans which were also approved.

I would like to think that we successfully represented NSW and voted in favour of those issues that deserved your support and voted against those issues that did not.

I thank you for these opportunities.

In addition I have been reviewing the current state of racing in the metropolitan area of Sydney and considering how we can consolidate and improve our circumstances.

If we refer to the club participation spreadsheet attached, we can see participation rates for all the metro clubs for the last 7 years. As well as the obvious decline in overall numbers for all metro clubs the single most important figure is the figure for Sydney Kart Club.

If we were to be generous we would expect that with the closing of Oran Park the figures for Sydney will be distributed amongst the remaining metro clubs, which would result in approximately 300-350 additional entrants per club per year.

I wonder if this will be the caseor will those additional karters wander offor simply disappear into the woodwork ?

Another issue for the metro clubs is the lack of a mid-tier competition, a position that was previously filled by the Premier State Cup for the past few years, it would appear that every state in the country has at least one if not more mid-tier series that prepare their karters and officials for competition at state and national championship level, and just more recently for CIK competition.

I put it to the clubs of this SKC that we as the Premier State need to consider the importance of a metro series in preparing our karters, clubs and officials for

successful involvement at these levels, and what we as individuals and clubs can do to implement a successful on-going series for commencement in 2011.

Item 5g – Industry Member – Position Vacant

Item 5h –Stewards Coordinator – Judy Preen

Firstly I would like to thank the State Executive for their support of our officials during the year and also thank the girls in the State Office for their assistance.

On-Line Training

Last AGM I reported to you that it was intended to have on-line training for officials in place for the beginning of 2010.

As this “on-line training” will form part of the overall race management/licensing system, however, other parts of the system need to be finalized and in operation before this section can be initiated, so it was “shelved” until the “Stewards’ Section” of C:MS is in use.

The On-line training program has been written, the National Officials Committee just need to decide the information that needs to go into it. I am advised by the State Executive that this on line training should be up and running by the end of 2010.

Stewards’ Section of C:MS system

Now that the timing section is in operation, the next section to be implemented in the race management system is the “Stewards’ Section”.

As we now have the smart-card system, and with that no paper licence log books, the “Stewards’ Section” of the program will have provision for the Stewards of the Meeting to note any penalties, written warnings and suspensions that are issued to competitors at a race meeting. This section will take the place of the Stewards noting the information in the competitor’s paper logbook. It will also have provision for the Stewards to give “upgrade signatures”.

Once the race meeting has been “uploaded” to the State Office this information will be put onto the respective competitor’s licence.

National Conference 5/6 June, 2010

I attended the National Officials’ Committee conference - this Committee is comprised of each State’s Officials’ Co-coordinator and the National Officials’ Co-coordinator).

At the conference we discussed a number of items, each of which were put forward by one of the States, where rules either needed clarification or needed to

be looked at with a view to being revised. Some new rules were also put up for discussion.

I thought it pertinent at this time to explain the reasons for the changes which have been implemented immediately, and resulted in the issue of some Addendums.

Addendum 19 – addition to rule 19.22 (a) *“When circumstances permit, the Officials of the Meeting may permit practice / carby session and racing timetable to be segmented.*

E.g. At State and National Championships, practice / carby session and race timetable for the finals may be split to allow practice / carby session and racing for approximately ½ of the total classes, followed by practice / carby session and racing for the remainder of the classes.”

Reason: To allow competitors to practice / carby session in more relevant conditions to their proposed race.

Addendum 20 - new rule -17.11(g) – *must hold a valid (Government issued) driver’s licence to drive a vehicle within the perimeter of AKA licensed premises and the heavy penalty for a breach of this rule.*

Reason: The practice of under-aged, non-licenced persons driving registered motor vehicles within AKA Licenced premises appears to be wide spread and must be stopped. The addition of this proposed new rule 17.11(g) will serve to eliminate this practice.

Addendum 21 - Rule 4.01(c) and (d) – this rule has been changed to include a reference to “on line training”, we also took out the necessity for officials to complete a training school by 30 June.

Reason: with “On-line training” to be implemented shortly, provision needed to be made in the rule. Some States were finding it impossible to conduct all schools prior to 30th June because of the distances to be travelled.

Some other matters discussed were:

‘Job Description for State Officials’ Co-coordinator’ – there is nothing in writing as to what the State Officials’ Co-coordinator’s job description is and to this end Brian Sparrow (National Officials’ Co-coordinator) has formulated a ‘job description’ for this and has asked each State for comment.

“Officials’ Accreditation Procedure” for each level of official i.e. Grade 1, 2, 3 and 4. Brian Sparrow wrote a set of procedures for each and has asked each State for comment.

Race Secretary Procedures Manual

I was recently requested by the State Executive to revise this State's "Race Secretary Procedures" policy document to bring it up-to-date to encompass the use of the C:MS licensing and race management program. This revision is almost complete. Once completed and approved for use, the Procedure Manual will be distributed from the State Office.

Item 5m – Junior Development Officer, Position 1 – Russell Grimson

The past year has been a little interesting with a few items causing a few disruptions to junior program causing the cancellation of the junior development camp in Wagga and some confusion with Tamworth.

I have requested over the time I have been the state junior development officer (10 years+) for clubs to include their preferred dates of when they want to conduct their training days to back up to their race days we have always set out our program as listed below for the following reasons.

Major Camp at the end of the summer school holidays in the central area and in the centre of NSW and the most convenient area geographically and for no other reason that is where the majority karters reside.

The second training day in the winter school holidays in the north of the state for obvious reasons it is warmer in the north of the state.

And the third day on the last weekend of the spring school holidays or on a weekend after the school exams have been conducted.

To obtain maximum results from our training day's we need to have sufficient time to program the event, promote and plan what we are doing. That's why we need to program and coordinate our trainers and officials and give them time to prepare their lectures etc and as volunteers give up their personal time by giving them lead time.

We have in NSW achieved a great deal in junior development and with the first batch of kids we put through our system now achieving in results i.e. Joseph Mawson Duel National champion in 2010.

We in NSW have funded our junior development program with the assistance of Mr. Les May from Dunlop Tyres and would like to thank Les for his ongoing support.

Our NSW program is the envy of the other states of what we have achieved and is done of no cost to the kids of NSW it is funded and run by AKA NSW.

Finally our training program would not function without the assistance of our training team and my assistant Karen Newton thanks to all and well done.

Item 5b – Proposed Changes to the Industry Representative State Policy Proposed by Dubbo Kart Club

3rd March, 2010.

Attention :- The Executive.

Dear Sirs,

Re:- Change of State Policy - Industry Member.

The Dubbo Kart Club is of the view the suggested changes to the State Policy - Industry Representative currently issued for Voting (Ref NSWPV/10-04) need to be re-worded to align with the present Constitution and to provide clarity.

First, this Policy should be named **State Policy - Industry Member of the Executive**. Clause 9. g) of the Constitution refers to such a position and differs from the identity of the "one Industry member" referred to in Clause 7 of the Constitution that appears to refer to an Industry Member of the State Karting Council.

Second, as Clause 9. 3) c) appears to permit for the election of only six (6) officers of the Executive, three (3) in any one year and three (3) named officers in odd numbered years this Policy should provide for the method of election of the seventh officer of the executive until the Constitution is amended to take care of that anomaly.

We thus suggest the following wording:-

Member Clubs are to be requested to submit recommendations of suitably qualified persons to for the position of Industry Member of the Executive to the Executive at least two (2) months prior to the Annual General Meeting in any even numbered year.

The Executive shall select a minimum of two (2) persons for Nomination from the list of recommendations and submit these Nominations to be voted on by the Members at the Annual General Meeting.

Such Nominations to be forwarded to the Members at least one (1) month prior to the Annual General Meeting together with details of why these Nominated persons are suitably qualified to be the Industry Member of the Executive.

This change to the present State Policy will allow Kartshop Retailers, Kartshop Wholesalers, Manufacturers of Karting Products and Importers of Karting Products the ability to be represented at the Executive level of the State Karting Council. This will assist in giving a balanced view of the Karting scene as a whole to the Executive and thus to the Australian Karting Association (NSW) Inc.

We request this alternative view be circulated to all Member Clubs prior to the Vote on this matter being finalised.

The Status of the "one Industry member" referred to in Clause 7 of the Constitution requires separate consideration.

Dear Sirs,

Re:- State Policy – SCRUTINEERING (SELF SCRUTINY)

The Dubbo Kart Club voted against the adoption of the Draft State Policy – SCRUTINEERING (SELF SCRUTINY) included for determination with Postal Vote NSWPV/10-07 as it considered it was too verbose, included excessive repetition of sections of the 2010 Karting Manual, was confusing, contained matters beyond the scope of Self-scrutineering and did not provide clear instructions to Competitors/Guardians and Race Officials, especially Race Secretaries and Scrutineers.

Karters, in the main do not continually refer to their Manual at Race Meetings so what hope is there that they would refer to three closely typed pages to undertake their own Scrutineering. Officials in NSW will now have to refer to both the Manual and three closely typed pages to ensure Karts in NSW were correctly entered.

The Policy now adopted will have to be constantly submitted to Postal Voting whenever Chapter 12 of the Manual is altered/corrected/added to at times between SKC Meetings.

AKA NSW AGM & SKC Minutes – 31st July 2010

We cannot comprehend what fitting Engine/Chassis Tags, Bar Codes, Replacement Tags and Technical Inspections have to do with Self-scrutineering. Scrutineering by the Officials at a Race Meeting have the responsibility of ensuring compliance with these matters.

We assumed this Policy was developed to assist all involved Self-scrutineering how best to implement procedures at a Race Meeting to ensure things ran smoothly, quickly and efficiently. We believe the attached Suggested Procedures would provide this result without having to create a State Policy and request the matter be placed on the Agenda for the next State Karting Council Meeting.

Arthurs suggested Procedures for the implementation of Race Meeting Self Scrutineering.

The responsibility in respect to the Scrutineering of a Kart and Apparel rides with a Competitor. See Chapter 12, Rule 12.01 of the 2010 Karting Manual.

Procedure.

1. Each Competitor/Guardian must first Scrutineer their Kart and Apparel in accordance with Chapter 12 of the 2010 Karting Manual then obtain, complete and sign a Scrutineer Record Sheet.
2. Each Competitor/Guardian must submit a completed and signed Scrutineer Record Sheet to the Race Secretary at the time of making a Race Meeting Entry.
3. On confirmation of acceptance of an Entry, the Race Secretary does either of the following:-
 - a) For D Grade Licence Holders, stamps the Scrutineer Record Sheet with either a "Paid" or "Entered" Stamp and advised the Entrant to present their Kart and Apparel to the Scrutineer to obtain a Nassau Panel Sticker.
 - b) For all other Entrants the Race Secretary retains the Scrutineer Record Sheet and provides the entrant with a Nassau Panel Sticker.
 - c) The Scrutineer is to, in respect to D Grade Licence Holders, undertake an inspection, retain the Scrutineer Record Sheet (for return to the

Race Secretary) and affix a sticker to the Nassau Panel of the inspected Kart.

- d) The Grid Marshall is to ensure that all Karts presenting at the Out Grid for Practice, Carburetor Session and Racing have the appropriate Nassau Panel Sticker affixed.

Please keep in mind that if metropolitan karters are constantly dipping into the kitty to pay for travel and accommodation the less they have for race entries and other items that keep them karting.

As administrators of the sport we have a responsibility to provided events for people to participate in. That's our job. Forcing clubs to go anything up to nine weeks without a race meeting is, in our opinion, not good management of the sport.

The closure of Oran Park has left a big hole in the Sydney Metropolitan area so we therefore request the SKC please review this policy.

- A social be held on Saturday night as a Reunion Dinner for all Karters Current or Past the cost of the dinner will included in the event entry Fee for the competing driver only We will need a coordinator for this function
- That promotional commemorative apparel be promoted including caps Shirts Beer coolers but these will have to be presold prior to the event. This can be done over the web but we will need a coordinator for this function

As you may appreciate there is great deal of preparation involved in conducting such a race meeting but it will require your support and indication if you support the concept will take part for the idea to proceed any further.
